- 3. accept full responsibility for any accidents, incidents, or losses to Permittee's personal property located on the Property; and
- 4. maintain adequate insurance on all of Permittee's personal property located on the Property;
- 5. release and forever discharge Company, its affiliates, subsidiaries, parent companies, successors and assigns for any and all claims and demands of whatsoever nature, whether for personal injury or death or loss of or damage to personal property in any way arising out of or resulting from any accident or incident which may occur during the presence of the Permittee or Permitee's visitors on Company's property, whether caused by the negligence of said Company, its agents, servants, officers or employees, or otherwise; and
- 6. indemnify and hold Company harmless from all losses, liabilities, damages, costs or expenses (including but not limited to reasonable attorneys' fees and other litigation costs and expenses) incurred by Company as a result of any claims or suits that Permittee (or anyone claiming by, under or through Permittee) may bring against any of Company to recover any losses, liabilities, costs, damages, or expenses related to or in connection with this agreement of any of the rights, responsibilities, obligations and liabilities provided for herein, regardless of whether or not caused in whole or part by the negligence or other fault of Company; and
