Federal Funding Update

Federal Funding Update

- Infrastructure Investment Jobs Act (IIJA) Passed by House
 - \$1.139B (FY22 FY26) \$228M/year (avg.) apportionment for NH
 - · Aligns with assumed funding for fiscal constraint
 - \$242M Advance General Fund Appropriations for NH
 - \$225M (\$45M/Year) in additional funding for bridges
 - \$17.3M (\$3.4M/Year) EV Infrastructure Program

Other federal aid plans Update (CARES, CRRSA, & ARP)

\$133M in COVID relief funds across all modes of transportation


Federal Funding Update

- \$242M Advance General Fund Appropriations
 - \$45M/Year in additional funding for bridges
 - \$3.4M/Year EV Infrastructure Program
- Assumptions
 - Fund is available only for current authorization (5 years)
 - Funds will be allocated in FY23 FY27 in Draft TYP



Strategy


 Allocate 15% of bridge funds to municipal bridge program (\$6.75M)





Strategy

 Allocate remaining \$38M/Year bridge funds to existing bridge projects to free up funds with greater spending flexibility

Strategy

- Increase mandated programs by 24%
 HSIP, TAP, CMAQ, Rec Trails, etc. (\$8.3M)
- Fund administrative project changes
- Fund anticipated project increases
- Fund recommended changes



State Funding Update State Funding

- Draft TYP constraint was based on reduced state revenue for Betterment and SB367 from 22-23 State Budget and Road Usage Fee study
- Current data shows actual road toll revenue trending slightly higher than plan for the first 4 month of SFY22


