

ROAD SAFETY AUDIT APPLICATION

This application is intended to identify locations within the state of New Hampshire that are experiencing fatal or serious injury crashes on public roads for improvement consideration through Road Safety Audits (RSA) utilizing the Highway Safety Improvement Program (HSIP).

The purpose of the HSIP is to achieve a significant reduction in fatalities and serious injuries on all public roads through highway safety improvement projects. All applications require approval through the local New Hampshire Department of Transportation (NHDOT) District Engineer, Regional Planning Commission (RPC)/Municipal Planning Organization (MPO), and Municipality prior to submission.

Once received, the submitting municipality will be notified to acknowledge receipt by the New Hampshire Department of Transportation's Safety Section.

Prior to evaluation, all applications will undergo review by the NHDOT Safety Section for completeness and concurrence of the details provided and for prioritization within the Highway Safety Improvement Program (HSIP), if applicable. Every application will be further evaluated by the HSIP Committee, which includes members from the NHDOT (Safety Section, Highway Design, Highway Maintenance, Planning and Community Assistance, and Traffic), Federal Highway Administration (FHWA), RPC/MPO representatives, and local agencies.

Applications will be categorized into annual groups (January-December) but can be submitted at any time throughout the year. Should the number of identified projects exceed the available funding for a given year, projects will be retained for a period of up to three (3) years. Municipalities will be updated on their application status once all applications for the given calendar year have been prioritized.

Please review the checklist below to ensure that your application includes all requested information and approvals. **Failure to provide this information will result in the application being returned to the applicant with a request for the missing information.**
